

Licence for use of the trademark Comfort Bultex®

Dear Customer,

As a seller of products containing Comfort Bultex® foam, we would like to point out that the Comfort Bultex® wordmark and logo ("the Marks") are registered trademarks belonging to Recticel NV, avenue des Olympiades, B-1140 Brussels ("the Company"). Its use for any purposes (including promotional purposes) requires the permission of the Company.

This permission shall be and is hereby granted, subject to your agreeing to the following conditions and limitations:

1. The Marks are to be used exclusively for upholstered products containing Comfort Bultex® foam in accordance with good upholstery practice and the document "A guide to your Comfort Bultex® guarantee conditions", appended to this licence (such items hereafter named "Products")
2. The Marks cannot be used in connection with the production or the sale of bedding equipment, including mattresses or pillows, or similar products.
3. When used with respect to sofas in France, Spain, Portugal, Italy, Monaco or San Marino, the Comfort Bultex® logo should be smaller than your own trademark / logo. Reference to the Comfort Bultex® quality should be a complementary sales argument in any presentation of the product.
4. The Marks can be used only for Products manufactured in the European Union, except for the United Kingdom.
5. The Marks cannot be used for Products sold in the United Kingdom.
6. All printed or electronic material (including amongst other any promotional or advertising material, press advertisements, catalogues, websites) in which the Marks appear shall be subject to the terms in the document "Use of the Trademark", appended to this licence.
7. The use of the Marks is free of charge and non-exclusive. It is strictly forbidden to transfer this licence.
8. Products should be constructed strictly in accordance with the document "A guide to your Comfort Bultex® guarantee conditions", appended to this licence.
9. You shall notify your customers of the above mentioned provisions and ensure their compliance therewith.

The Company does not guarantee the validity of the trademark rights. You waive any claim vis-à-vis the Company for any damage or cost you may suffer in the event of a violation of any third party rights by use of the Marks.

The provisions of this agreement and the specific conditions for use of the Comfort Bultex® Marks and the Comfort Bultex® foam can be modified by the Company from time to time, in order to improve the quality standards of the foam, to improve or make more uniform the

presentation or identification of the Marks, to better position and protect the Marks on the market, to adapt the foam to market evolutions and changing technological needs.

This agreement shall commence on the date of your signed acceptance of its terms and shall continue as long as you purchase Comfort Bultex® foam, subject to termination by either of us giving 3 months' written notice, without prejudice to other arrangements that may have been agreed upon regarding existing stocks.

The Company is entitled to terminate this agreement immediately if you breach any of the clauses in the present agreement or if the shareholding proportions within your company are changing considerably (e.g. sale of more than 50% of the shares, change of the controlling majority etc.)

The Company has the right to request samples of and inspect any product incorporating Comfort Bultex® foam as well as the production facilities and may terminate this agreement, if in its opinion, such goods do not conform to the criteria stated in the document "A guide to your Comfort Bultex® guarantee conditions".

For guarantee conditions, please refer to the document "Comfort Bultex® 100% guarantee policy", appended to this licence.

Belgian legislation applies to the present agreement. The legal venue for any disputes that may arise from this agreement or connection herewith is Brussels.

Please sign the attached copy of this letter to signify your agreement to the above conditions.
